

Terms and Conditions

"AED250 Cashback" offer for Credit Card digital application, self-serving, using the FAB Mobile Banking App

- 1. The offer is valid from 22nd June 2022 to 31st December 2022.
- 2. The offer is applicable to individual customers who do not hold a Credit Card with First Abu Dhabi Bank. The customer must be considered "new-to-card"/"new-to-product".
- **3.** The offer is only applicable to individuals who apply for a Credit Card, using the FAB Mobile Banking App. This is referred to as "self-serve" digital journey.
- **4.** To participate in this offer, the customer needs to apply for a Credit Card using the FAB Mobile Banking App, self-serve. The card should be booked before or up-to the 31st December 2022 and the card should be activated within 30 days from card issuance (the "Offering Period") to be eligible for the offer.
- **5.** The offer does not include Credit Card applications made physically through First Abu Dhabi Bank branches.
- **6.** The offer does not include Credit Card applications made through staff-assisted tablets, in First Abu Dhabi Bank branches.
- 7. The customer will only be eligible for the offer if their digital application has been completed successfully, approved and their Credit Card has been activated, using the FAB Mobile Banking App as per the clause 3 above.
- **8.** The cashback amount will be credited to the same account which the customer has applied from within 60 days of application for the eligible customer only.
- **9.** First Abu Dhabi Bank may, in its sole discretion, exclude any customer from the offer, including but not limited to customers who do not meet the campaign criteria.
- **10.** The General Terms and Conditions of First Abu Dhabi Bank and Master Credit Card Terms & Conditions apply in addition to the terms and conditions of this offer.
